Disagreement with any of the course requirements or policies below, which are specific to my class, makes me ineligible to take the course.

- 1. I must contact the DirtBike Tech office prior to 10 business days before the date of the class if I wish to cancel and obtain a refund, less a \$25 administrative fee. If DirtBike Tech cancels or reschedules a course, the student will receive a full refund or placement in another equivalent class at no additional charge, at the student's discretion. Refunds or rescheduling for reasons of discontinuation, dismissal, or lack of attendance, while infrequent, will be considered on a case-by-case basis.
- 2. I am able to ride and balance a bicycle. Balancing is not taught during any DirtBike Tech course.
- 3. I am at least 6 years old by the first day of the course to enroll in the **Youth Dirt Bike School (Youth DBS)**; and at least 12 years old by the first day of the course to enroll in the **Adult Dirt Bike School (DBS)**.
- 4. If I am not able to safely control the motorcycle during every exercise, I understand I may not be able to complete this entire course, and will not receive a completion card. For my safety and that of the other students, the instructor may discontinue my on-cycle participation at any time, at the instructor's discretion.
- 5. If I am under 18, I will provide parental or guardian signature as approval to take any course.
- 6. I will sign a waiver of liability indicating that I understand that I might be injured in this course.
- 7. I understand that if I cause a behavior or discipline problem during the course, the instructor must dismiss me from the course. If dismissed from the course under this condition, I will not be eligible for a refund. Also, if I wish to complete the course at a later time, I must re-register and pay again the full tuition. A behavior or discipline problem is defined as any action which could result in myself or any other student being put at risk and/or causing a distraction which reduces the opportunity for the other students to concentrate and learn.
